(ENTRY SUMMARY) ABI TRANSACTIONS HAVE BEEN MODIFIED TO ACCEPT THE NEW
FDA/BTA PRIOR NOTICE DATA FOR FOODS. PLEASE NOTE THAT FOR THE 'EI',
THIS IS APPLICABLE ONLY TO ENTRY SUMMARIES CERTIFIED FOR CARGO RELEASE.

INPUT DATA REQUIREMENTS FOR FDA/BTA:

IN ORDER TO MINIMIZE THE IMPACT ON ABI FILERS, THE CURRENT OGA RECORD
FORMATS WILL BE UTILIZED. FOR FDA-SPECIFIC DATA, THE CURRENT 'OI' AND
'FD01' THROUGH 'FD05' RECORDS WILL BE USED. FDA/BTA PRIOR NOTICE DATA
WILL BE SUBMITTED AS REQUIRED UTILIZING NEW AFFIRMATIONS OF COMPLIANCE
AND ASSOCIATED AFFIRMATION OF COMPLIANCE QUALIFIERS IN THESE RECORDS.

PK1 THRU PK0	(CURRENT AFFIRMATIONS OF COMPLIANCE FOR PACKAGE/CAN CODES). 'PK1' SHOULD BE USED FOR THE FIRST CODE, 'PK2' FOR THE SECOND, ETC. 'PK0' REPRESENTS THE 10TH CODE. THESE CODES SHOULD BE USED AS NEEDED.

PVL PRIVATELY OWNED VEHICLE LICENSE NUMBER. SHOULD BE USE FOR ANY ENTRY COMING IN VIA PRIVATE VEHICLE. CONDITIONAL AS APPLICABLE.

PVP PRIVATELY OWNED VEHICLE FOREIGN STATE/ PROVINCE. SHOULD BE USED FOR ANY ENTRY COMING IN VIA PRIVATE VEHICLE. CODE APPLIES TO NON-U.S. REGISTERED VEHICLES. ENTER VALID FOREIGN STATE/PROVINCE CODE OR NAME. CONDITIONAL AS APPLICABLE.

PVC PRIVATELY OWNED VEHICLE COUNTRY OF REGISTRATION. VALID ISO COUNTRY CODE. CONDITIONAL AS APPLICABLE.

BOL MASTER BILL OF LADING - SURFACE. THIS IS OPTIONAL BASED ON MODE OF TRANSPORT. FIRST FOUR POSITIONS MUST BE VALID SCAC CODE.

AWB AIR WAYBILL. OPTIONAL FOR AIR MODE OF TRANSPORT.

AWH HOUSE AIR WAYBILL. OPTIONAL FOR AIR MODE OF TRANSPORT.

IN ADDITION TO THE ABOVE AFFIRMATIONS OF COMPLIANCE, THE FOLLOWING DATA ELEMENTS IN THE FD01 THROUGH FD05 RECORDS WILL BE MANDATORY FOR ITEMS SUBJECT TO PRIOR NOTICE:

IF PRIOR NOTICE DATA IS REQUIRED FOR AN FDA LINE ITEM BUT IS NOT SUBMITTED, FILERS WILL RECEIVE A WARNING MESSAGE (ERROR CODE 'FDP') FOR THE FDA LINE STATING "REQ'D PRIOR NOTICE NOT SUBMITTED". GUIDELINES WILL BE PROVIDED ON COMPLIANCE.

PRIOR NOTICE DATA PRESENTED VIA AFFIRMATIONS OF COMPLIANCE WILL BE SUBJECTED TO BASIC EDITS SUCH AS VALID DATE FORMATS, VALID COUNTRY CODES, VALID DDPP, ETC. ANY DATA NOT PASSING THESE EDITS WILL BE REJECTED WITH THE APPROPRIATE EXISTING ERROR CODE.

ANY REQUIRED PRIOR NOTICE DATA WILL BE TRANSMITTED BY CBP TO FDA ALONG WITH THE CURRENT FDA COMPLIANCE DATA, NO SOONER THAN 5 DAYS IN ADVANCE OF THE ESTIMATED ARRIVAL UTILIZING THE CBP CARGO SELECTIVITY TIME FRAMES AND THE EXISTING CBP/FDA INTERFACE. THEREFORE, FILERS ARE ENCOURAGED TO FILE ELECTRONICALLY AS SOON AS POSSIBLE TO AVOID ANY POTENTIAL DELAYS.

OUTPUT DATA FOR FDA/BTA:

FILERS WILL CONTINUE TO RECEIVE THE SAME FDA ACTION MESSAGES THAT THEY CURRENTLY RECEIVE FOR AN ENTRY VIA THE 'RR' ABI APPLICATION (I.E. - "MAY PROCEED", "FDA REVIEW", ETC.).

ADDITIONALLY, THERE WILL BE A NEW ABI APPLICATION TO PROVIDE PRIOR NOTICE-SPECIFIC LINE ITEM PROCESSING RESULTS. THIS NEW APPLICATION WILL BE 'BN'. THE 'BN' TRANSACTION WILL ALLOW CBP TO TRANSMIT THE RESULTS OF FDA PRIOR NOTICE PROCESSING TO FILERS AT THE FDA LINE-ITEM LEVEL. THE NEW APPLICATION CONSISTS OF TWO OUTPUT RECORD TYPES, 'BN01' AND 'BN02'. THE 'BN01' RECORD WILL BE RETURNED ONCE FOR EACH ENTRY, AND THERE WILL BE AS MANY 'BN02' RECORDS AS THERE ARE PRIOR NOTICE FDA LINE ITEMS FOR THE ENTRY. 'BN' IS OUTPUT ONLY.

THE NEW 'BN' TRANSACTION HAS BEEN CONSTRUCTED FOR USE IN RETURNING PRIOR NOTICE STATUSES FOR SEVERAL TYPES OF TRANSACTIONS, INCLUDING ENTRY. FOR THE PURPOSE OF THIS MESSAGE, WE ARE LIMITING THE 'BN' DISCUSSION TO ENTRY DATA. FOLLOWING ARE THE LAYOUT REQUIREMENTS FOR THE 'BN' APPLICATION:
